Discussion: Senator Plumb presented the 3rd Substitute, which was adopted by the Senate. The substitute reintroduces language that had been removed in previous versions of the Bill. Senator Brammer motioned to amend the Bill by removing the word "not" on line 511, but this motion failed. Senator Weiler expressed opposition to the Bill due to certain language limiting the age of operation without a helmet. In response, Senator Plumb indicated her willingness to amend the Bill to address the concern and motioned to circle the issue. Upon returning to the Bill, she

clarified that under current Code, operators of Class III e-bikes under the age of 21 are required to wear helmets. With this clarification, Senator Weiler expressed support for the Bill.
