The sponsor said that he doesn't know how the other GRAMA Bills will fare, but there will have to be some coordination as they progress through the legislative process.

This Bill enacts provisions related to certain information provided to the legislative auditor general.

Discussion: Senator Brammer presented the Bill and Senate Amendment 2, which was adopted. The amendment, requested by several agencies, specifies that the Office of the Legislative Auditor General ("Office") must select an arbitrator who is licensed to practice law in Utah and does not have a known, direct, or material interest in the outcome of the arbitration, the entity, or the Office. Senator Kwan referenced the fiscal note of \$0 and asked whether the arbitrator would be compensated or if they are already on staff. The sponsor explained that the Bill applies to rare circumstances, and he does not anticipate any claims of attorney-client privilege regarding records sought by the Office in the upcoming year. However, if a claim of privilege is deemed valid during arbitration, the Office will cover the arbitrator's fee. If the claim is deemed invalid, the audited agency will be required to pay the fee.

Discussion: Senator Fillmore presented the Bill. There was no discussion.

Bill: SB 280 – Retail Facility Amendments

Discussion: Senator Vickers presented the Bill. There was no discussion.

Bill: 2nd Substitute SB 133 – Metal Purchase and Theft Amendments

Sponsor: Senator Todd Weiler

Floor Sponsor: Representative Christine F. Watkins

UASD Position: Oppose

This Bill concerns the purchase and theft of metal including catalytic converters.

Discussion: Senator Weiler presented the 2nd substitute for SB 133, which was adopted yesterday. The substitute waters down the original Bill by moving its controversial aspects to be discussed over the interim. The revised Bill clarifies language regarding catalytic converter purchases under the Pawnshop, Secondhand Merchandise, and Catalytic Converter Transaction Information Act. It also creates a new criminal offense for metal or catalytic converter theft and removes penalty provisions related to this theft from certain generally applicable criminal theft statutes, due to the establishment of the new offense. Additionally, the Bill updates the industry definition for metal regulation requirements and offenses and adds the new metal or catalytic converter theft offense to the list of offenses concerning a pattern of unlawful activity.

Senator Fillmore asked why a new crime is being created. The sponsor explained that individuals who steal catalytic converters cause tens of thousands of dollars in damage in exchange for only a few hundred dollars, and the Bill aims to enforce the documentation of catalytic converter sales. Senator Kwan inquired whether the 2nd substitute is supported by small businesses and groups such as Chamber West. The sponsor clarified that the substitute softens the original Bill, moving all controversial parts to the interim. Senator Thatcher spoke in support of the Bill, emphasizing that it addresses organized crime, the frequency of these crimes, and the collateral damage they cause.

Bill: 1st Substitute HB 81 – Fluoride Amendments

Sponsor: Representative Stephanie Gricius Floor Sponsor: Senator Kirk A. Cullimore

UASD Position: Support

This Bill addresses provisions related to water fluoridation and prescription fluoride supplements.

Discussion: Senator Cullimore presented the Bill, with Senators Weiler and Plumb speaking in opposition. Senator Fillmore asked about the difference between fluoride being added to water and fluoride being prescribed for individual consumption, as well as the distinction between natural fluoride and fluoride manually added to water. The sponsor explained that added fluoride is fluoridated acid, while naturally occurring fluoride is sodium fluoride. Senator Fillmore also inquired if there is a recommended dosage of fluoride. The sponsor clarified that, while there is no recommended dosage, the CDC has noted that fluoride provides the best treatment when applied topically, not ingested. The Bill does not prohibit the consumption of fluoride but allows individuals who do not wish to consume it to opt out of being forced to drink it. Senator Fillmore spoke in support of the Bill.
