Bill: 2nd substitute HB 23 – Insurance Modifications

Discussion: The sponsor presented the Bill. No discussion ensued.

## Bill: 1st substitute HB 68 – Insurance Funds Amendments

## Bill: 1st substitute HB 89 – Water Transfer Amendments

### Bill: 2nd substitute SB 80 - Water Fee Amendments

Discussion: The sponsor presented the Bill. No discussion ensued.

This Bill addresses funding and planning for water infrastructure.

Discussion: The sponsor presented the Bill. No discussion ensued.

Outcome: 1st substitute HB 285 passed out of the Senate.

Bill: 2nd substitute SB 277 – Government Records Management Amendments

Sponsor: Senator Michael K. McKell

Floor Sponsor: Representative Jefferson Moss

**UASD Position: Tracking** 

This Bill creates the Government Records Office (the Office) within the Division of Archives and Records Service (the Division) and replaces the State Records Committee (the Committee) with the Director of the Office, who is an attorney with knowledge and experience relating to government records law and makes other changes relating to government records.

Discussion: The sponsor presented the Bill. Senator Hinkins asked whether 80% of GRAMA requests are handled at the local level, to which the sponsor confirmed. He then inquired if the Bill would reduce the 150-day processing time, and the sponsor stated it would speed up the process.

Senator Riebe questioned how the Bill could have no fiscal note if it establishes a new Division. The sponsor clarified that there is an ongoing fiscal note of \$450,000. She then expressed concerns about transparency, but the sponsor assured that the hearing process remains unchanged and open to the public. When asked whether a committee would still be involved with the Director, the sponsor confirmed there would be no committee but maintained that transparency would be upheld.

Senator Johnson asked if media reports suggesting the Bill would slow GRAMA processing were inaccurate. The sponsor stated that the Bill would improve efficiency. Senator Stratton voiced support, while Senator Plumb raised concerns that it could deepen public distrust in the government.

Bill: 1st substitute SB 327 – Public Sector Labor Organization Definition Amendments

The sponsor confirmed that it would. No further discussion followed.
