Discussion: The sponsor introduced the Bill. Representative Albrecht asked whether it includes budgeted figures from previous budgets that have already been spent. The sponsor clarified that the Bill does not address budgets but instead focuses on making cash investment reports more publicly accessible.

Discussion: The sponsor introduced the Bill. Representative Hawkins asked whether the Department of Natural Resources is part of the executive branch, and the sponsor confirmed that it is. Representative Gricius then inquired about the Bill's impact on the Utah Lake Authority. The sponsor explained that the Bill seeks to ensure consistency among various water agencies in their use of taxpayer funds. Representative Gricius followed up by asking whether the Bill's reporting requirements are redundant. The sponsor clarified that the existing provisions in the code are inadequate, making the legislative change necessary. Representative Albrecht spoke in support of the Bill. No further discussion followed.
